#### **Instruction to the applicant :**

The EOI is to be submitted in **two separate sealed envelopes (one for Form II and III and second envelope for price bid)** and both the envelopes are to be placed in another envelop. The outer envelope superscripted as “EXPRESSION OF INTEREST FOR PURCHASE OF RESIDENTIAL ACCOMODATION” should be duly sealed and delivered with contact details at the office of Central Waqf Council by **20<sup>th</sup> June, 2020**.

#### **Criteria for selection of premises**

The following criteria with or without modification shall be adopted for short listing of premises:-

- a) The location, approach, ambiance, distance from office location, suitable premises as per required specification given here at Form I
- b) Title of the premises
- c) Statutory compliance (Sanction of building plan ,completion/ occupancy certificate, NOC from fire ,and other required formalities
- d) Present status of building
- e) Age of building
- f) Construction quality

The properties would be shortlisted as per above based factors with gradation/ marks to be decided by the CWC.

### **GENERAL TERMS AND CONDITIONS**

#### **Procedure for selection of premise :**

- 1, CWC would open and scrutinize the EOI , submitted by intending parties with in the scheduled period taking into consideration the selection criteria.
- 2, The authorized committee would visit the site for physical verification, location, observe the status of premises ,CWC may carry out other verification for its satisfaction for which all assistance shall have to be provided by owner/applicant.
- 3, The Proposal (s) not accompanied by the documents as per the requirement is/ are liable to be rejected.
- 4, CWC reserve the right to accept or reject the proposals or negotiate for reduction in the quoted price.

5, CWC is not bound to give reason for rejection of any EOI.

6, The decision of the CWC would be final and binding on all applicants.

7, The CWC shall issue LOI in the name of premises owner on approval of the proposal and shall enter in to an agreement to purchase on receipt of clear due diligence report and settlement of all terms and conditions , subsequently a sale deed shall be executed on fulfillment of other conditions.

8, The stamp duty and registration shall be payable on the instrument of transfer/ transfer deed and any other document towards the purchase of premises shall be borne by CWC.

9, All other pending dues prior to purchase will be borne by owner

10, The EMD of unsuccessful applicant will be refunded without interest after finalization of proposal/short listing and the EMD of successful applicant would be adjusted in the total consideration without interest. EMD deposited shall be liable forfeiture in the following event and reason;

- a) If the owner fail to get the NOC if any from the local authority in respect of transfer of license / development rights in favor of CWC with in stipulated period
- b) If the owner increases the rates during negotiation or at any other stage
- c) If the title of property is defective and the owner fails to rectify with in the time given of pointing out the anomaly by law firm/CWC
- d) if the applicant withdraw the EOI
- e) Non fulfillment any condition as agreed by the owner

#### **TERMS and CONDITIONS FOR PAYMENT**

1, CWC will make payment to the owner based on agreed price.

2, CWC shall release payment in the following manners.

#### **STAGE I**

25% of agreed cost would be released on execution of agreement for sale of premises

#### **STAGE II**

- A) Balance payment will be released at the time of execution of sale deed in favor of CWC and compliance of all other terms conditions. The purchaser (CWC) shall make payment subject to applicable Tax deducted.
- B) The CWC shall make payment by way of Cheque/RTGS to the company /owner.
- C) CWC will not pay any brokerage to any person/ Agent/Real estate consultant for the proposed  
Transaction / deal.

#### **JURISDICTION**

All dispute arising out of this agreement subject to Jurisdiction of Court in Delhi.
