- 4. A copy of the Utilization certificate of 1<sup>st</sup> installment is enclosed. Further it is certified that no UC is pending for this project.
- 5. Utilization of the above-mentioned amount by the State Government is subject to the terms and conditioned at Annexure-II.
- 6. Utilization Certificate for this grant should be submitted by the State in the prescribed format within 12 months of the closure of financial year. - 7. The State Government should ensure that a board containing information as per Template enclosed at Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed.
