I am directed to convey sanction of the President for release of an amount of Rs. 174,47,94,000/-(Rupees One Hundred Seventy Four Crore Forty Seven Lakh Ninety Four Thousand Only) as 1<sup>st</sup> installment of Central Share to the Government of Sikkim for implementing the scheme "Pradhan Mantri Jan Vikas Karyakram" for Minority Concentration Areas in State of Sikkim for the year 2021-22 as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Sikkim through CAS, Reserve Bank of India, Nagpur. Cheque may be issued in favor of Principal Secretary, Finance, Revenue & Expenditure Department, Government of Sikkim.

2. The State Government should ensure that proportionate share of 50% of State share for the project mentioned at Annexure-I is released to the implementing agency along with Central share. The approval is subject to condition laid down by EC as detailed in the minutes of the meeting, conveyed to concerned vide OM No MSDP-13/51/2021-MSDP-MOMA dated 08.11.2021.

3. The expenditure is debitable to Demand No.69, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64–Pradhan Mantri Jan Vikas Karyakram for minorities, 64.00.35 Grant for creation of capital assets the year 2021-22.

4 Since it is a fresh release for the plan of PMJVK, no UC is pending. Utilization Certificate for this grant should be submitted by the State in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guideline of PMJVK, (i) Quarterly Progress Report, (ii) Utilization Certificate, (iii) Report regarding release of the State share and (iv) Photographs of the Assets so far created, should also be furnished.

5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be/has been selected for the projects mentioned at Annexure-I and that duplication will not take place.

6. The State Government should ensure that a board containing information as per Template enclosed at Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed.

 7. This is to certify that the present sanction/ expenditure is covered under MEP for the month of November, 2021 and Integrated Finance Division (IFD) has approved the expenditure during the 3<sup>rd</sup> quarter of the financial year 2021-22.

8. The amount will be credited to the State Govt. account in RBI as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM. No. 1(13) PFMS/FCD/2020 dated 23.03.2021

9. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

10. Utilization of the above-mentioned amount by the State Government is subject to the terms and conditioned at Annexure-II.

11. The amount of Rs. 55.07 crore has been re-appropriated from Major Head 2552.00.450.24.00.35 to Major Head 3601.06.101.64.00.35 vide re-appropriation order no 27/2021-2022(NER) dated 22.11.2021 of Budget Division, Ministry of Minority Affairs.
