- 2. - 3. The State government should ensure that proportionate share of 50% of State share for the projects mentioned at annexure –I is released to the implementing agency along with Central share.
- 4. A copy of the Utilization certificate of 1st installment is enclosed. Further it is certified that no UC is pending for this project.
- 5. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development

- 9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.
