

Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Mhow Cantonment Minority Concentration Town (MCT) to Government of Madhya Pradesh for the year 2013-14 for Indore District.

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs.49,02,000/- (Rupees forty nine lakh two thousand only)** as 1st instalment for the year 2013-14 to the Govt. of Madhya Pradesh of the total sanctioned amount of **Rs.98,05,000/- (Rupees ninety eight lakh five thousand only)** for implementing the scheme "Multi Sectoral Development Programme" for Mhow Cantonment Minority Concentration Town (MCT) in Indore district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Madhya Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate State share for the projects mentioned at annexure is released to the implementing agency alongwith Central share .
3. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Central Plan Scheme (Sub Major Head), 378 -General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants, 04 - Multi sectoral Development Programme for minorities, 04.00.35 - Grant-in-aid for the year 2013-14.
4. The sanction is issued on the commitment given by the State Govt. that town/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
5. Since it is a fresh release for the plan of MsDP, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) work plan for the requisitioned amount with milestones and time frame may also be furnished.
6. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.



7. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

8. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.

9. This sanction issues with concurrence of IFD vide their Dy. No 402/IFD dated 25/09/2013. It is noted at S. No. 90 in the Grant-in-aid Register.

- vii. Grantee will ensure that there is no duplication of work.
- viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
