- The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure -I and also that duplication will not take place.
- Since it is a fresh proposal for the plan of MsDP, no UC is pending. Utilization Certification for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. After completion of projects, a permanent display would be installed.
