Subject: Grant in aid for organizing Orientation Programme under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Blocks to Government of Sikkim for the year 2013-14.

Sir,

I am directed to convey the sanction of the President for release of an amount of Rs. 2,00,000/- (Rupees Two lakh only) for the year 2013-14 to the Govt. of Sikkim for organizing one Orientation Programme each in 02 blocks, viz; Mangan & Chungthang in the State of Sikkim. One Orientation Programme in each block will be organized for training of the officials concerned and dissemination of required information regarding MsDP. The expenditure for the programme would be on account of preparation of venue, arrangement of Audio-visual instruments, printed material, like, handout, pamphlets, etc., resource persons, vehicles, refreshment and miscellaneous items. A report should be sent to the Ministry along with photographs of the programme.

The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Central Plan Scheme (Sub Major Head), 378 -General-(Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -other grants, 04 - Multi sectoral Development Programme for minorities, 04.00.31 - Grant-in-aid for the year 2013-14.

3. Since it is fresh release, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the date of the Sanction Order.

4. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditions at Annexure-I.
