  and Minorities) -Other Grants (Minority Head), 04 Multi sectoral Development Programme for
  minorities in selected minority concentration districts, 04.00.35 Grant for creation of capital assets
  for the year 2013-14.
- 3. A copy of the Utilization certificate of 1<sup>st</sup> instalment is enclosed. Further it is certified that no UC is pending for this project.
- 4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year.
