I am directed to convey the sanction of the President for release of an amount of Rs.3,69,000 /- (Rupees Three Lakh Sixteen Nine Thousand only) as 1st instalment for the year 2013-14 to the Govt. of West Bengal for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Block, (Chanchal) in Malda district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of West Bengal through CAS, Reserve Bank of India, Nagpur.

- The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" 2. Grant-in-aid to State Government, 04- Grants for Central Plan Scheme (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants, 04 -Multi sectoral Development Programme for minorities, 04.00.35 - Grant for creation of capital assets for the year 2013-14.
- Since it is a fresh release for the plan of MsDP, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificates and (iii) Report regarding release of the State share in case of innovative projects may also be furnished.
- The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
- The State Government should ensure that a board containing information as per Template 5. enclosed at Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed.

- 6. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
- 7. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.
- 8. This sanction issues with concurrence of IFD vide their Dy. No 1187/IFD dated 28.3.14. It is noted at S. No. 241 in the Grant-in-aid Register.
