- 4. A copy of the Utilization certificate of 1st instalment is enclosed. Further it is certified that no UC is pending for this project.
- 5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
- 6. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and the requisitioned amount with milestones and time frame may also be furnished.

- 7. The State Government should ensure that board containing information as per template enclosed at Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed.
- Funds should be released by the State Govt. to the implementing agencies immediately upon 8. receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
- Utilisation of the above mentioned amount by the State Government is subject to the terms and 9. conditioned at annexure-II.
- This sanction issues with concurrence of IFD vide their Dy. No. 1021/IFD dated 6.02.14. It is 10. noted at S. No. 174 in the Grant-in-aid Register.
