- 4. A copy of the Utilization certificate of 1st instalment is enclosed. Further it is certified that no UC is pending for this programmme.
- 5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
- 6. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. - Utilisation of the above mentioned amount by the State Government is subject to the terms and 9. conditioned at annexure-II.
