Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for minorities to Government of **Bihar for the year 2011-12 for West Champaran District**. Sir,

In continuation to this Ministry's sanction letter of number dated 25.6.2009, 24.2.2010,5.3.2010, 3.9.2010, 30.12.2010, 18.2.2011,30.3.2011,11.11.2011 and 8.2.2012, I am directed to convey the sanction of the President for release of an amount of Rs. 1,98,67,000/- (Rupees one crore ninety eight lakh and sixty seven thousand only) as 1<sup>st</sup> installment (50% of total central share) of the total sanctioned amount of Rs. 3,97,33,000/- (Rupees three crore ninety seven lakh and thirty three thousand only) for the year 2011-12 to the Govt. of Bihar for implementing the scheme "Multi Sectoral Development Programme for minorities" for West Champaran district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Bihar through CAS, Reserve Bank of India, Nagpur.

- 2. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head-"3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -Other Grants, 04 Multi sectoral Development Programme for minorities, 04.00.35 Grant for creation of capital assets for the year 2011-12.
- 3. Since it is fresh release for the revised plan. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of the financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount may also be furnished.
- 4. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
- 5. The sanction is issued on the commitment given by the State Govt. that villages/ locations having a substantial minority population will be selected for the projects and also that duplication will not take place. The State Government should ensure that proportionate share of 50% of State share is released to the implementing agency. The conditions conveyed vide this Ministry's letter no. 3/5(6)/2008-PP-I dated 7.3.2012 may also be adhered to.
- 6. The sanction would be subject to the condition that the approval of the Directorate of Employment and Training of the State for the proposal is obtained before implementation of the scheme to ensure that there is a need for such a proposal, it should also be ensured that proposal is as per norms,

Funds under MsDP will not be used for purchase of land, repairs, maintenance, staff and adjustment of any taxes and running of the scheme. State Govt. should ensure these conditions are met before starting the work. The amount would be scrupulously deducted if any deviation is found at the stage of the implementation of the scheme.

- Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
- Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at Annexure-II.
- This sanction issues with concurrence of IFD vide their Dy. No. 903 /IFD dated 23.03.12. It is noted at S. No. 188 in the Grant-in-aid Register.
