Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for minorities to Government of **Uttar Pradesh for the year 2011-12 for Bahraich District.**

Sir,

In continuation to this Ministry's sanction letter of even number dated 01.07.09, 19.03.10, 24.05.10, 19.08.10, 09.12.10 and 27.12.10, I am directed to convey the sanction of the President for release of an amount of **Rs. 1,69,59,000/- (Rupees one crore sixty nine lakh and fifty nine thousand only)** as 2<sup>nd</sup> installment (50% of total central share) of the total sanctioned amount of **Rs. 3,39,18,000/- (Rupees Three crore thirty nine lakh and eighteen thousand only)** for the year 2011-12 to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for minorities" for Bahraich district as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of 50% of State share (i.e. Rs. **85.995 lakh**) for the project of construction of inter-college and construction of boys hostel in Polytechnic released to the implementing agency alongwith Central share of Rs. 169.59 lakh.

3. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 - General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -Other Grants, 04 - Multi sectoral Development Programme for minorities, 04.00.35 - Grant for creation of capital assets for the year 2011-12.

4. A copy of the Utilization certificate of 1<sup>st</sup> instalment is enclosed. Further it is certified that no UC is pending for this programme.

5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for Drinking water supply schemes and also that duplication will not take place.

6. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount may also be furnished.



The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.

8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.

10. This sanction issues with concurrence of IFD vide their Dy. No. 300 dated 04.11.2011. It is noted at S. No. 61 in the Grant-in-aid Register.


