Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for minority concentration districts (MCDs) to Government of **Uttar Pradesh for the year 2011-12 for Bulandshahr District.**

Sir,

In continuation to this Ministry's sanction letter of even number dated 12.02.09, 16.02.10, 26.11.10, and 16.12.10, I am directed to convey the sanction of the President for release of an amount of **Rs. 7,40,00000/- (Rupees seven crore and forty lakh only)** as 1st instalment (50% of total central share) of the total sanctioned amount of **Rs. 14,80,00000/- (Rupees fourteen crore and eighty lakh only)** for the year 2011-12 to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for minorities" for Bulandshahr district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that State contribution of Rs. 194.95 lakh for construction of Govt. ITI would be borne by the State Govt.
3. The Polytechnic is to be constructed as per the estimates prepared as per Schedule of Rates of the State Government approved by a competent engineering department.
4. The ITI is to be constructed as per the estimates prepared as per Schedule of Rates of the State Government approved by a competent engineering department contained in the DPR submitted to the Ministry and advice given by the Ministry of Labour & Employment.
5. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -Other Grants, 04 - Multi sectoral Development Programme for minorities, 04.00.35 Grant for creation of capital assets for the year 2011-12.
6. Since it is a fresh release no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount with milestones and time frame may also be furnished.

The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
8. Funds should be released by the State Govt. to the implementing agencies only after all the conditions stipulated while approving the projects are fulfilled. Ministry of Finance; parking of funds at any level is strictly prohibited.
9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.
10. This sanction issues with concurrence of IFD vide their Dy. 905/IFD dated 14.03.12. It is noted at S. No 162 in the Grant-in-aid Register.
