Indira Awas Yojana (IAY)

- (a) The State Government should ensure that the IAY houses would be distributed in villages having highest minority population and BPL families selected from the approved waiting list, even if they belonged to communities other than the minority communities, strictly in order of their ranking in the list as per the IAY guidelines.
- (b) State share would be provided.
- (c) The list of the villages, along with the number of houses to be constructed, would be furnished by the State Government.
- (d) To prevent duplication, the Government of Uttar Pradesh should ensure that the IAY units funded under MsDP were reflected in the State Action Plan of the scheme and the Central Ministry concerned informed.

Construction of anganwadi centres

- (a) The State Government should ensure that the centres were located in such villages/mouzas, having the highest concentration of minority population.
- (b) The State Government assured to provide a list of villages where these centres would be constructed.
