Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral development programme for minorities to Government of Uttar Pradesh for the year 2008-09 for Bijnor District.

Sir,

I am directed to convey the sanction of the President for release of an amount of Rs. 15,82,45,000 (Rupees fifteen crore eighty two lakhs & forty five thousand only) as 1st instalment (50% of total central share) of the total sanctioned amount of Rs. 31,64,88,000.00 (Rupees thirty one crore sixty four lakhs & eighty eight thousand only) for the year 2008-09 to the Govt. of Uttar Pradesh for implementation of the scheme "Multi sectoral development programme for minorities" for Bijnor district as per details enclosed at Annexure. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

Indira Awas Yojana

- (a) The State Government should ensure that the IAY houses would be distributed in 428 villages of 11 blocks having more than 30% of minority population and BPL families selected from the approved waiting list, even if they belonged to communities other than the minority communities, strictly in order of their ranking in the list as per the IAY guidelines.
- (b) State share would be provided.
- (c) The list of the villages, along with the number of houses to be constructed, would be furnished by the State Government.
- (d) To prevent duplication, the Minority Welfare & Wakf Department of the Government of Uttar Pradesh would ensure that the units funded under MsDP were reflected in the State Action Plan of the scheme and information also sent to the Ministry concerned.

Construction of building of Primary Health Sub-Centres (PHSC):

- (a) The State Government should ensure that the centres were located in areas having the highest concentration of minority population, NRHM construction norms, design, specification would be followed and the State share would be provided.
- (b) The list of the centres with location should be furnished. To prevent duplication, the Government of Uttar Pradesh would ensure that the centres funded under MsDP were reflected in the State Action Plan of the scheme and information also sent to the Ministry concerned.

Anganwadi Centres:

- (a) The State Government should ensure that the centres were located in villages/mouzas having the highest concentration of minority population.
- (b) The State Government assured to provide a list of villages where these centres would be constructed.

Installation of India Mark-II hand pumps:

- (a) The State Government should ensure that the Centre and State sharing ratio would be as per the ARWSP and these hand pumps would be installed in sourceless or inadequately sourced villages having the highest proportion of minority population.
- (b) The list of the villages where these hand pumps were to be installed with location would be furnished.
- (c) To prevent duplication, the Government of Uttar Pradesh would ensure that the assets funded under MsDP were reflected in the State Action Plan of the scheme and information also sent to the Department concerned.

Construction of ITI building:

- (a) The State Government should ensure that the building design, specification were as per the norms of the 'National Council for Vocational Training' (NCVT) or 'State Council for Vocational Training' (SCVT).
