Subject: Grant in aid under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram (erstwhile MsDP) for **Minority Concentration Blocks to Government of Arunachal Pradesh for the year 2018-19 for Kra Dadi District, Arunachal Pradesh.**

Sir,

I am directed to refer to the sanction letter of even number dated 27.09.2017 and to convey the sanction of the President for release of an amount of **Rs. 30,15,000 (Rupees Thirty Lakh Fifteen Thousand Only)** as 2nd installment to the Govt. of Arunachal Pradesh for implementing the scheme "Pradhan Mantri Jan Vikas Karyakram (PMJVK)(erstwhile MsDP) for **Minority Concentration Blocks in Kra Dadi District, Arunachal Pradesh**, for the year 2017-18 during 2018-19, as per the details enclosed at Annexure-I. The non-recurring grant may be released to the Govt. of Arunachal Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of State share for the projects mentioned at Annexure-I is released to the implementing agency along with Central share.

3. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Governments, 06- Centrally Sponsored Schemes (Sub Major Head), 101 Central Assistance/Share (Minor Head), 49 - Multi sectoral Development Programme for minorities, 49.00.35 - Grant for Creation of Capital Assets for the year 2018-19.

4. A copy of the Utilization certificate of 1st installment is enclosed. Further, it is certified that no UC is pending for this project.

5. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Pradhan Mantri Jan Vikas Karyakram (PMJVK) (i) Quarterly Progress Report, (ii) Utilization Certificate and (iii) Report regarding release of the State share in case of innovative projects may also be furnished.

6. The sanction is issued on the commitment given by the State Govt. that villages/locations mentioned in Annexure-I and also that duplication will not take place.




