Sir,

In continuation to this Ministry's sanction letter of number 3/3(2)/2008-PP dated 15.07.2013 and 28.09.2016. I am directed to convey the sanction of the President for release of total amount of Rs. **1,68,24,800/- (Rupees One Crore Sixty Eight Lakh Twenty Four Thousand and Eight Hundred only)** as 3rd instalment for the year 2013-14 to the Govt. of Arunchal Pradesh for implementing the scheme "Pradhan Mantri Jan Vikas Karyakaram (erstwhile MsDP) for Minority Concentration Districts" for Lower Subansiri District as per the details enclosed at Annexure -I. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 49 - Multi sectoral Development Programme for minorities, 49.00.35 Grant for creation of capital assets the year 2018-19.

3. **The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.**


