Subject: Grant in aid for engagement of Block Level Facilitators (BLFs) under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram for Minority Concentration Areas (MCAs) to State of **Arunachal Pradesh**.

Sir,

In continuation to this Ministry's sanction letter of even number dated 28.09.2017. I am directed to convey the sanction of the President for release of total amount of **Rs. 43,20,000 /-** (**Rupees Forty Three lakh Twenty Thousand only**) to the Govt. of Arunachal Pradesh for engagement of Block Level Facilitator (BLFs) each in 24 MCAs in the state of Arunachal Pradesh. The sanction amount includes monthly remuneration of 24 BLFs for the period of 2018-19 @ Rs. 10,000/- salary and Rs. 5,000/- for TA/DA at a total cost Rs. 15,000/- per per BLF per month for the period of 12 months as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Arunachal Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head-"3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64-Pradhan Mantri Jan Vikas Karyakram for minorities, 64.00.31 Grant in Aid General for the year 2019-20.

3. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guideline of Restructured Multi sectoral Development Programme,

4. A list of the engaged BLFs should be submitted to the Ministry along with their qualification date of joining, contact number and the name of block where they have been deputed. Utilization of the above mentioned amount by the State Govt. is subject to the terms and condition at Annexure-II



