Some of the important development in the Ministry of Minority Affairs during the Month of May, 2019 are as follows:

1. State/UT-wise allocation of funds under Pradhan Mantri Jan Vikas Karyakaram (PMJVK) has been conveyed to the State Govts/UT administrations vide DO dated 27.05.2019 with the request to submit fresh projects proposals for the year 2019-20 and proposals for subsequent instalments for the earlier sanctioned projects.
2. The online portal of Pradhan Mantri Jan Vikas Karyakaram (PMJVK) has been restructured and made live for submission of project proposals by the States/UTs.
3. Action has been initiated for mapping of projects sanctioned under erstwhile MsDP/PMJVK scheme. States/UTs have been requested to furnish geo-tagging details of such assets.
4. Zonal Review Meeting with State Waqf Boards to evaluate the implementation of the Qaumi Waqf Board Taraqqiati Scheme was convened on 03.05.2019 at Bengaluru (Karnataka) in which Karnataka and Chhattisgarh Waqf Boards participated.
5. The process of scrutiny of applications of Haj Group Organisers (HGOs) for Haj 2019 has been completed. A total basic quota of 50,000 seats and additional quota of 10,000 seats have been allocated to 725 Haj Group Organisers for Haj 2019. The additional quota of 10,000 seats allocated to HGOs will be charged by them at the applicable rates of Haj Committee of India.
6. 620 deputationists against posts of administrative and medical contingent have been selected on short term deputation to Consulate General of India, Jeddah, Saudi Arabia to render assistance to Haj pilgrims during Haj 2019.
7. One Building Selection Committee (BSC) and One Building Selection Team (BST) visited Saudi Arabia for selection of buildings for accommodation of Haj pilgrims going through HCoI for Haj 2019.
