Subject: Grant in aid under the Centrally Sponsored Scheme of **Pradhan Mantri Jan Vikas Karyakram** to Govt. of Assam.

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs. 1,71,00,000/- (Rupees One Crore Seventy One Lakh Only)** as 1<sup>st</sup> installment for the year 2019-20 to the Govt. of Assam for implementing the scheme "**Pradhan Mantri Jan Vikas Karyakram**" (PMJVK) in Minority Concentration Areas (MCAs) of State of Assam as per the details enclosed at **Annexure I**. The non-recurring grant may be released to the Govt. of Assam through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of 50% of State share for the projects mentioned at **Annexure-I** is released to the implementing agency along with Central share.

3. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64-Pradhan Mantri Jan Vikas Karyakram for minorities, 64.96.35 Sawachitta Action Plan for the year 2019-20.

4. Since it is a fresh release for the plan of PMJVK, no UC is pending. Utilization Certificate for this grant should be submitted by the State in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guideline of PMJVK, (i) Quarterly Progress Report, (ii) Utilization Certificate, (iii) Report regarding release of the State share and (iv) Photographs of the Assets so far created, should also be furnished.

5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at **Annexure-I** and also that duplication will not take place.

6. The State Government should ensure that a board containing information as per Template enclosed at **Annexure-III** is displayed at the site. After completion of projects, a permanent display would be installed.

7. This is to certify that the present sanction/expenditure is covered under MEP for the month of March 2020 and Integrated Finance Division (IFD) has approved the expenditure during the 4<sup>th</sup> quarter of the financial year 2019-20.



Utilization of the above mentioned amount by the grantee is subject to the following terms and conditions:

- b. All release by the State/UT should be made through PFMS and EAT module only.
- c. The expenditure incurred by the grantee shall be open for inspection by the sanctioning authority/ Comptroller & Auditor General of India/Internal Audit by the Chief Controller of Accounts of the Ministry of Minority Affairs.
- d. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
- e. Grantee shall not divert any part of the grant to any other activities.
- f. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
- g. Grantee shall endeavor to achieve the quantified and qualitative targets.
- h. Grantee will ensure that there is no duplication of work.
- i. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
