Clarifications to issues raised by HGO Applicants for Haj 2024

Clarity on tax return document	The statement reads: "The annual turnover of the applicant HGOs will be from Haj and/or Umrah operations in any of the preceding two years (excluding 2020 and 2021, which were hit by COVID-19 pandemic)." Can you please clarify what year tax returns are needed to meet the turnover requirement? Is it 2019 or 2022? Or is it 2018 and 2019?	The policy and the clarification issued by Ministry is amply clear, the Turnover should be for any of the two preceding two year (excluding 2020 and 2021 which were hit by Covid pandemic). Thus, applicant needs to deposit financials for FY 2019-20 and FY 2022-23.
Clarity on Umrah turnover document	We Have been allocated Quota for 51 Pilgrims for Hajj 2023. We have some queries regarding the new application for Hajj 2024 The audit & ITR for the current year i.e. 2023-24 is not possible as we are in mid of the year and the financial year is not complete. So what do we have to do in such a scenario? Can we show Umrah Turnover for the year 2022-23 which is more than the required Rs. 1.5 core. But when we are creating login and we select experience category than Umrah section by default becomes 0 and we can add any number of years for Umrah Experience. Please guide us and advise so that we can start our Hajj 2024 Application.	Since the financial year 2023-24 is not yet completed, you can provide turnover mentioning receipts from Umrah pertaining to FY 2022-23 and need to provide all documents as per Clause 14 of HGO Policy for Haj-2023 (now part of 2024). Umrah definition is same as mentioned in Point-II of Notice for announcement of HGO policy for Haj 2024.
Clarity on tax return document	My company ----- holds the registration --- --/CAT-II/-----23. With one year of prior Hajj experience, ----- I am unsure about the documents related to Previous Accommodation Details, Air Tickets Details and Foreign Currency Purchase. Could you please advise on the specific documents needed for Hajj 2023? Furthermore, I would like clarification on whether any additional letters are required for submission. As of now, I am aware that the Auditing Report for the fiscal year 23-24 has not been submitted.	Documents as specified in the policy may be submitted. Furthermore, since the financial year 2023-24 is not yet completed, you can provide turnover mentioning receipts from Umrah pertaining to FY 2022-23 and need to provide all documents as per Clause 14 of HGO Policy for Haj-2023 (now part of 2024). Umrah definition is same as mentioned in Point-II of Notice for announcement of HGO policy for Haj 2024.
Clarity on Umrah turnover amount	I have a total turnover of Rs 3,40,00,000/- approx., out of which Haj turnover is Rs. 2,50,00,000/- approx.. The remaining Turnover of Rs. 90,00,000/- is from air ticketing and not Umrah. What is to be mentioned in the Umrah turnover column?	Applicant can declare 'Zero' turnover from Umrah and proceed to submit the application.
