NOTICE

Subject: Financial transactions of Combined Haj Group Organisers (CHGOs) in Kingdom of Saudi Arabia (KSA) for Haj-2025–reg.

Attention is invited to this Ministry's circular No. HAJ-15/5/2024-HAJ-MoMA dated 29.11.2024 publishing the list of eligible/ ineligible HGOs. Subsequently, the H portal has been made live for Stage 2 registration from 04.12.2024. Based on the applications received from CHGOs on Haj portal along with hard copies of acknowledgements and other mandatory documentations, Ministry has issued registration and allocation certificates to eligible CHGO applicants and constituent members for Haj 2025.


2. Further, with respect to the policy of KSA on financial transactions for Haj Group Organisers (HGOs) as operationalised w.e.f. Haj-2024, CHGOs are required to deposit amounts for finalisation of service arrangements of their respective pilgrims in KSA into the account of Haj Committee of India (HCol) through the online portal of State Bank of India (SBI) developed for this purpose. The URL of the portal is:

3. The amount collected as above would be remitted to the designated account of Consulate General of India (CGI), Jeddah, and subsequently CGI Jeddah will transfer the remittances of each CHGO to the respective e-Haj accounts of each CHGO in KSA so that the CHGOs can then conduct their financial transactions in KSA.

4. In order to maintain a proper trail and record of each transaction, prior to making the first transaction, the CHGOs must necessarily send the information as mentioned at Annexure-A to this notice to the email ID: support-hajdivision@nic.in for record and reference of the Ministry.
